Gentlemen,

The Board and the Search Committee are asking all members, if possible, to be at our rehearsals until June 21. During the next weeks we are having our third and fourth candidates for West Towns director audition. Each of these men has extensive experience directing male a capella singing. Three candidates have national reputations as singers. Two candidates are active judges in contests. All have experience in arranging.

On June 14 the rehearsal will begin with warm-ups. At 7:30 P.M. the candidate will take over and direct us for an hour to an hour and a half. On June 9 we interviewed the final candidate and we will develop a plan for his audition for June 21.

The committee is asking that each of us give each candidate our full attention during his audition. This is the time for all of us to discuss each candidate after he auditions. Your views are important. Mark Johnson, Ken Keever and I are your representatives. Ed, Craig and John will be communicating with members of the Music Committee and

evaluating technical points on directing by each candidate. The Board, in the persons of Jack Fagan and Daryl, has been involved at every step.

If we receive no other applications from qualified candidates, the Search Committee will submit an evaluation of each candidate to the Board. The Board makes the final decision because it is the only legal body that can commit funds and make contracts.

In a few weeks the Board will either tell us that we have a new director or that we must continue the search. In any case the Music Committee has made plans for our musical leadership to help us compete in September.

I would like to take this time to thank the Music Committee for being very cooperative in making the auditions by our guests so comfortable. All of us on the Search Committee would also like to thank all of you for your patience. We believe we will be presenting well qualified candidates to the Board. All of us will be evaluating each candidate at the same time. Enjoy the process.

National Anthem Performance

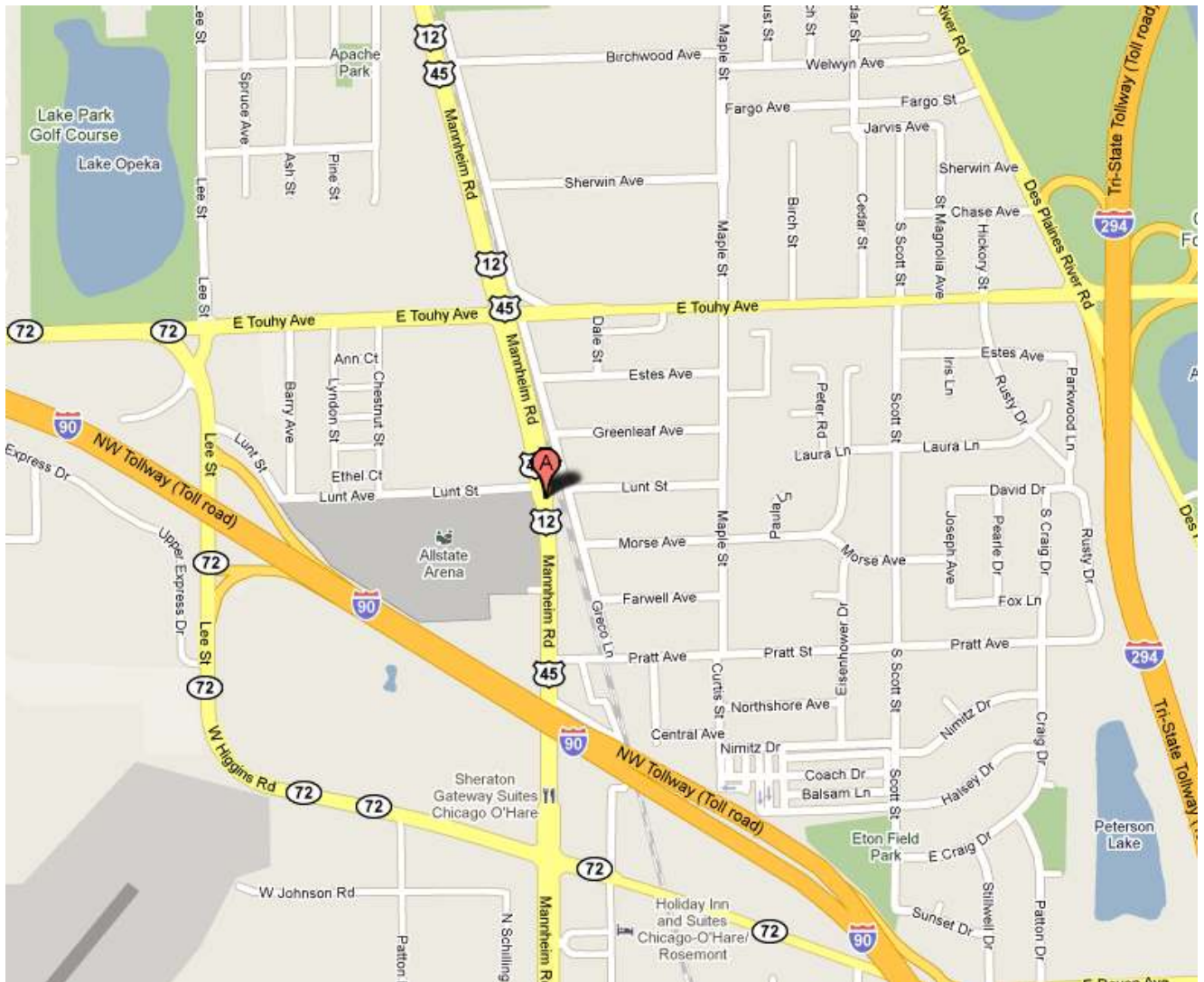
This coming Saturday, June 19 we are performing the National Anthem at the **Chicago Rush Arena Football** game.

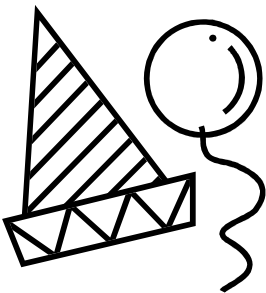
